MEMBERSHIP REQUIREMENTS / PROCEDURE:

1. Complete application and supplemental questionnaire and send to P.O. Box address with payment of all dues, fees, and assessments.
2. Your application will be reviewed. You will be notified (preferably via email) if approved.
3. Applicants are subject to criminal record check at the discretion of the Club.
4. You must be a member of the NRA or pay the NRA assessment. You must remain an NRA member to renew.
5. You must be a U.S. citizen.
6. Denied applicants will receive a full refund of all dues and fees paid.
7. Approved applicants must attend a new member orientation prior to using the facilities. Associate and junior members are strongly encouraged to attend the orientation.
8. Club handbook, bylaws, membership badge and gate access card will be provided at the new member orientation.

NRA MEMBERSHIP REQUIRED: To verify NRA membership, include original or copy of the label from your NRA magazine, or a copy of your NRA membership card, or an acknowledgement email from the NRA. If not currently an NRA member, the NRA Assessment fee will be used by DRRC to acquire an NRA membership on your behalf.

MEMBERSHIP YEAR: Our membership year is from July 1st – June 30th. New member dues are pro-rated based on quarter.

MEMBERSHIP RENEWAL BILLING CYCLE: Regardless of when you join all member renewal statements are mailed in early May and are due by June 30th, but you are encouraged to remit prior to June 15th of expiring year to ensure uninterrupted access to the facilities. Unpaid member's access is shut off after the July membership meeting.

LOCATION: The club physical address is 27787 SE Hwy. 224, Eagle Creek, Oregon.

SENIOR MEMBERSHIP: The primary person completing the application is designated the Senior member. Senior members may sponsor Associate and/or Junior members as part of their membership.

REGULAR ASSOCIATE/JUNIORS: Associate membership limited to spouse or significant other. Regular Associate and Junior Members may only use the club while accompanied by a Senior Member, except as noted at events otherwise open to the public. Must be under 18 years to qualify as a Junior Member.

FAMILY ASSOCIATE: Limited to spouse or significant other. Provides a second gate access card for the Family Associate, allows use of the club without Senior Member being present. Family Associate must also attend a new member orientation. Junior member dues are included.

WORK HOURS: All Senior Members are expected to put in at least 8 hours a year of volunteer service to the Club, beginning with the first full year of membership. A \$150.00 work hour fee will be assessed upon renewal if work hours are not completed. Associate and Junior members may contribute to the Senior Member's work hours requirement.

Initiation Fee	\$100.00	First time applicants only.
Senior Member Annual Dues	\$200.00	Prorated for new applicants.
Associate Member Annual Dues	\$10.00/\$80.00	Regular spouse Associate (\$10) must be with Senior Member when at range, Family spouse Associate (\$75+\$5 for HID card) gets second access card and may come to range on own. Prorated for new applicants.
HID Gate Access Card	\$ 5.00	Deposit for proximity card used for accessing club property and Clubhouse. May only be used by the Senior Member.
Building Assessment	\$ 25.00	Assessed for first three years of membership, included in first prorated year.
Contingency Fund Assessment	\$ 50.00	Assessed to new applicants and rejoining members, dedicated funds held and used solely for emergencies or as directed by the board.
NRA Assessment	\$ 45.00	Assessed at time of joining or renewal for non NRA members or those showing expired membership. Used to pay NRA dues on behalf of member.
Work Hour Assessment	\$200.00	Begins with renewal after first full year. Waived if member has contributed at least 8 hours of verified volunteer work for DRRC.
Junior Member Annual Dues	\$ 5.00	Per junior member unless part of family membership then no cost.
